

Marin Dance Theatre's Participation Policies

1. Students are expected to attend all scheduled classes and rehearsals. Students are expected to be prompt and prepared when class begins. Attendance will be taken. Please notify the school in the event of an absence. A missed class may be made up within the same quarter as when the absence occurred.
2. **STUDENTS MUST BE DROPPED OFF AND PICKED UP IN THE STUDIO LOBBY.** Please ***DO NOT*** drop off your child in the parking lot or ask that he/she meet you there after class. Students must stay in the building and are not to wander around or off the St. Vincent's property. Your child's safety is of the utmost importance to us.
3. For students taking more than one class, be sure to send a snack and a water bottle with your dancer (items should be clearly marked with child's name). Students are to eat only in the designated eating areas. We ask that students clean up after themselves. PLEASE NOTIFY THE OFFICE IF YOUR CHILD HAS FOOD ALLERGIES.
4. Smoking cigarettes, e-cigarettes, vaping, alcohol or other drug use is expressly forbidden on the MDT premises or the grounds of St. Vincent's at any time. Such usage may constitute grounds for dismissal from the MDT program.
5. Students are expected to dress according to the MDT dress code as specified. This includes no dangling earrings or other jewelry, no nail polish, no visible tattoos (temporary or permanent), and no body piercings (ears ok). Girls' hair must be put neatly in a bun or pulled back if it's too short for a bun. No gum chewing is allowed.
6. The MDT office telephones are available to students for emergency and/or schedule change use only.
7. All faculty, parents and students will treat each other with respect and courtesy. Please be aware that we share St. Vincent's campus with other tenants. Please drive slowly and carefully when entering/exiting the St. Vincent parking lot (**speed limit is enforced at 10 mph**) and do not walk through areas marked "off limits" by the Catholic Youth Organization. Dogs are **NOT ALLOWED** on campus or in studios **AT ANY TIME.** We ask for your compliance in this campus-wide policy.
8. Bicycles, skateboards, scooters, etc. are not allowed on the St. Vincent's campus.

Marin Dance Theatre Dress Code:

Introduction to Dance and Pre-Ballet

Girls: So Danca D-156 Princess cut light pink cap-sleeve leotard, white socks, pink ballet slippers

(NO tutus or skirts)

Boys: Black shorts, white t-shirt, white socks, black ballet slippers

Elementary – Hair must be combed neatly in a bun (or pulled back if too short for a bun)

Girls: So Danca D-156 Princess cut black cap-sleeve leotard, pink tights, pink ballet slippers

Boys: Black shorts, white t-shirt, white socks, white ballet slippers

Junior & Senior - Hair must be combed neatly in a bun (or pulled back if too short for a bun)

Girls: Motionwear #2524 or black Mirella camisole leotard, #207C childrens, M207L or M207LM adults, pink tights, pink ballet slippers (*no rhinestones, velvet leotards or colored straps*)

Boys: Black tights, white t-shirt, white socks, white ballet slippers

- The 1st Quarter dates are September 3, 2019 – November 2, 2019. Tuition is due Monday, August 19, 2019.
- The 2nd Quarter dates are November 4, 2019 – February 1, 2020. Tuition is due Monday, October 21, 2019.
- The 3rd Quarter dates are February 3, 2020 - March 28, 2020. Tuition is due Tuesday, January 21, 2020.
- The 4th Quarter date are March 30, 2020 - June 5, 2020. Tuition is due Monday, March 16, 2020.

Enrollment: A completed registration packet, annual registration fee, and tuition payment must be submitted at time of enrollment. A student may not attend classes until this administrative requirement has been met. A student may enroll in classes at any point during the quarter. The quarterly tuition will be prorated based on the start date.

Annual Registration Fee: All students enrolled in the school are required to pay the one-time annual \$70 registration fee at the beginning of their initial enrollment.

Billing and Payment Procedures: The regular school program is from September, 2019 to June, 2020, and is divided into four quarters. Tuition for each quarter is due and payable **two weeks PRIOR** to the start of the session. The fee for returned checks is \$30.00.

Billing Disputes: Any billing disputes must be addressed *in writing* and sent to the attention of the Bookkeeping department. You may email questions regarding your account to billing@mdt.org. Please allow up to a week for a response.

Tuition Payments: Families will register and pay online. If you cannot make a credit card payment online, you may submit a check (or cash) to the billing office. If no one is in the office, there is a secured metal “payment” box near the front door. Please place the payments inside an envelope and label it to the attention of “Bookkeeping”. A 10% pre-payment discount will apply if the full year’s tuition is paid by August 19, 2019.

Late Fees: Tuition payments not received by the predetermined due dates will be subject to a late fee. A late fee of 10% of the balance due will be applied. Delinquent accounts may be turned over to the Board of Directors for further action.

Overdue Accounts: MDT is a non-profit organization that relies heavily on prompt tuition payments in order to offer quality dance education and manage ongoing day-to-day expenses. Overdue accounts are subject to the late fees as described above. **Please note: New or continuing registrations will not be accepted quarter to quarter if your account is delinquent. Additionally, students with delinquent accounts will not be eligible to participate in performances.**

Termination and Refunds: *Registration and tuition fees are non-refundable.* The school does not offer refunds for missed classes or withdrawal after the quarter has started. Refunds for extenuating circumstances are at the discretion of the MDT Board.

Performance Fees: All students are required to pay Performance fees **in full** by the due date. **Students with delinquent accounts will not be eligible to participate in performances.** Scholarship students **are** required to pay performance fees.

Parent Participation: Parents must sign the Parent Participation Program Contract, stating they understand they will be called upon to volunteer at MDT and that they agree to participate. Parents with children in a performance must volunteer to help with that specific performance or pay an opt-out fee of \$100 (Springfest & Summerfest) or \$200 (Sophie & the Enchanted Toyshop).

Invoicing: Parents/guardians will be invoiced for the academic year in four quarterly billings. **Invoices are generated automatically for each quarter unless the school is notified in writing that a student will be withdrawing from the program.** Invoices are sent out two weeks prior to the due date.

Withdrawal: MDT must be notified when a student will be withdrawing from the school. If MDT is not notified, *in writing*, billing will continue on a quarterly basis. Marin Dance Theatre reserves the right to refuse admittance to classes and to terminate participation with MDT based on student and/or parent conduct, or if their account is delinquent.

Tuition for Mixed-level Students: Please note that students at mixed levels will pay the lower tuition fee until 50% or more of their classes are at the higher level, which then the higher tuition rate will prevail. If a student is advanced mid-quarter to a higher level, the lower tuition rate applies until the beginning of the next quarter, at which time the student will pay the new rate.

Sibling Discount: Families with more than one student enrolled at MDT shall pay the highest-level tuition first, with the next highest-level sibling eligible for a 20% discount, and subsequent siblings eligible for a 25% discount. If the oldest sibling is awarded a scholarship, the next sibling is eligible for a 20% discount, with subsequent siblings eligible for a 25% discount.

Trial/Audition Class: MDT offers trial/audition classes for any new student. The trial/audition class will be free of charge if the student does not end up enrolling in classes. If a student enrolls, they will be subject to the full tuition for the level in which they are registering. Auditions are not a guarantee of placement with MDT and are at the discretion of the MDT Faculty.

Make-up Classes: MDT has designated holidays and breaks during the school year. If your student’s class falls on an observed holiday, they can take a make-up class of the same level on an alternative day. Similarly, if your child misses a class (due to illness, etc.) they are also eligible to take a make-up class on an alternative day. We ask that students take their make-up classes during the same quarter in which the class was missed.
